- No person shall hold a specific position on the Board of Directors for more than two full consecutive terms.
- Regional Directors shall be responsible for providing a focus for Federation activity at a regional level and providing a communications conduit for The Federation and regional members.

POSITION: PRESIDENT

NOMINEE: TANYA BEHARDIEN

BIO: Tanya Behardien is the Executive Director of OneSky Community Resources, an accredited multiservice organization with over 200 staff serving communities in the South Okanagan Similkameen region. REASON: My ED, Michelle Bell of Cowichan Valley Youth Services is currently the Vancouver Island Region Director for The Federation of Community Social Services of BC, and through her sharing I have been able to witness and learn about the powerful impact The Federation has on informing and guiding best practices within Social Services around BC. Working in silos is not an option, particularly in rural and semi-rural communities where resources are even more limited. Far too often social service organizations find themselves working in isolation instead of striving for more collaborative, wrap-around services.

If given the opportunity to be the Vancouver Island Region Director I would strive to continue to strengthen and gain new connections with other Social Service Providers, and take part in important dialogues regarding the strengths and obstacles encountered in this complex and rewarding field.

Vancouver Island is made up of richly diverse communities with differing needs, experiences, and access (or lack of access) to supports and resources. These communities deserve representation, and in my previous experience as well as my current roles as a youth and family counsellor and Team Lead of community outreach I feel I can advocate and represent the successes, frustrations, and hopes of the youth and families that access many different social services. Their voices are powerful, they are the experts of their lived experiences and hold valuable information and feedback regarding how social services are thriving and where they need some work.

POSITION: VANCOUVER COASTAL REGION DIRECTOR NOMINEE: MARNIE GOLDENBERG

BIO: Marnie Goldenberg brought over 20 years of not-for-profit experience when she joined Family Services of Greater Vancouver 3 years go. Previously Marnie held senior roles in human resources, organizational development, and program management, and served as an interim executive director. As a consultant to the sector, Marnie supported many organizations in the areas of governance, program development and evaluation.
