Hello, we are writing to you regarding the temporary Personal Protective Equipment (PPE) program that CLBC announced to you on Wednesday, February 10th, 2021. (Click <u>here</u> to read the announcement)

It has been brought to our attention that the majority of PPE orders placed on the <u>COVID-19 Supply Hub</u> <u>website</u> are not using the instructions outlined in the <u>step by step guide</u> that was included in our message to you.

Please remember to follow the process outlined in the guide as this will ensure your PPE orders are free to you. Skipping any step in this process could result in your organization being billed.

Another important item to address is to please make sure that your PPE purchases do not exceed 0.15% of the <u>annualized</u> contract value of <u>your residential contracts only</u> for Fiscal Year 2020/2021. If this amount is less than \$100, the limit will be set at \$100. Service providers who contract directly with home sharing providers should consider your home sharing providers PPE needs when placing your order.
