BC Commitment

- Immunization of BC population by end of Sep 2021
 - All residents over 18 year of age (4.3M)
 - Small group of people with risk of very adverse outcomes (~180K) will be prioritized
- Roll out
 - Phase 1 and 2: Priority populations
 - Phase 3 and 4: Age-based approach: oldest to youngest + small group of highly at risk immunosuppressed patients
- Consistent approach across health authorities
- Learning from best practice
- Ongoing management of pandemic and outbreaks

High-Risk Population

- Residents, staff, and essential visitors to long-term care and assisted living
- Individuals assessed for and awaiting long-term care
- Hospital health care workers who may provide care for COVID-19 patients
- Remote and isolated Indigenous communities

- Seniors aged 80+ who are not yet immunized
- Indigenous seniors aged 65+, Elders, and additional communities not yet immunized
- Hospital staff, community GPs and medical specialists not yet immunized
- Vulnerable populations in select congregated settings
- Staff in community home support and nursing for seniors

General Population

People aged 79 to 60, in five-year increments:

- 79 to 75
- 74 to 70
- 69 to 65
- 64 to 60
- People aged 69 to 16 who are clinically extremely vulnerable

People aged 59 to 18, in five-year increments:

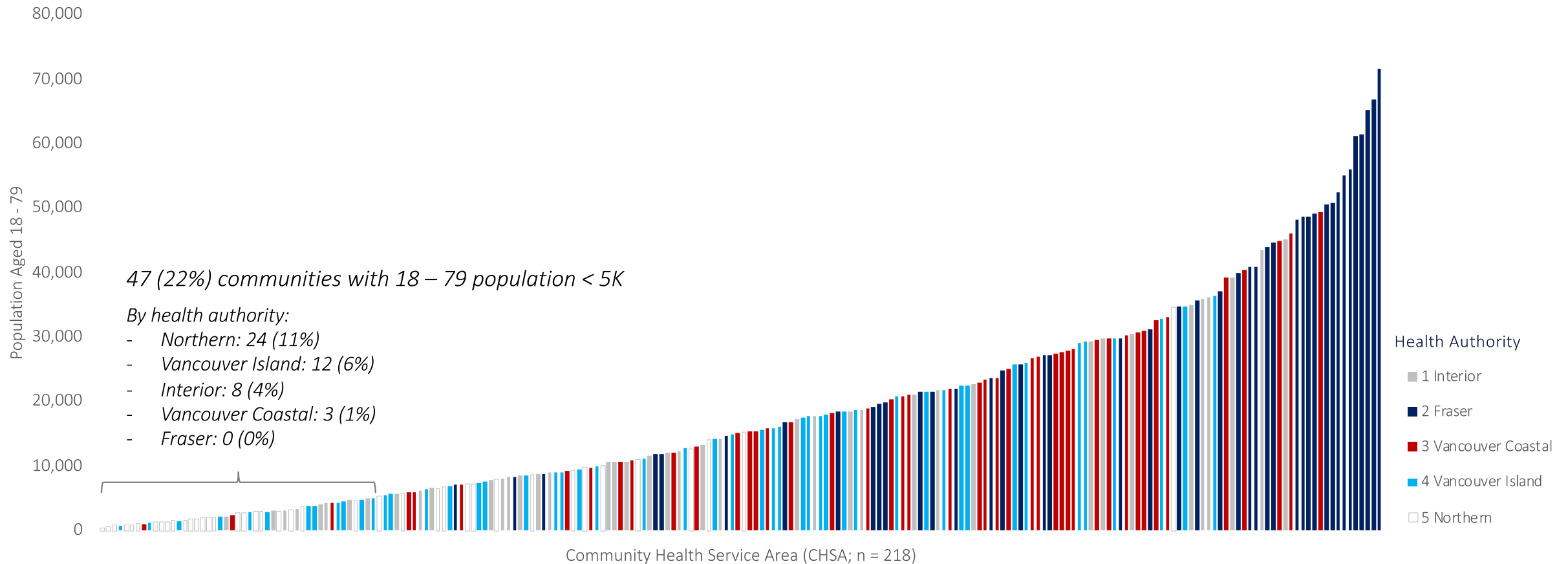
- 59 to 55
- 54 to 50
- 49 to 45
- 44 to 40
- 39 to 35
- 34 to 30
- 29 to 25
- 24 to 18

Once additional vaccines are approved and become available, people between the ages of 18 and 64 who are front-line essential workers or work in specific workplaces or industries may be included in the later part of Phase 3.

The timeline for BC's COVID-19 Immunization Plan may change based on vaccine availability. Information last updated: January 19, 2021.

COVID-19 IN BC

Vaccine Supply

- Two vaccines currently approved and in use in BC
- Both require 2 doses – currently administered 42 days apart
 - 4.3M people x 2 doses = 8.6M vaccinations
- Both have “cold-chain” requirements
- Waiting regulatory approval
 - AstraZeneca: requires 2 doses but no cold-chain requirement
 - Johnson & Johnson: requires 1 dose and no cold-chain requirement
- Vaccines ordered from National Operations Centre (NOC); delivered weekly directly to location to preserve cold chain
- Supply fluctuates due to manufacturer capacity

Communications Basics

- Consistent provincial communications campaign in multiple languages, across multiple accessible channels
- **Communications Objectives:**
 - Communicate and create clear expectations on timing of when different groups of people will get vaccinated.
 - Provide accurate, easy to understand information on vaccine safety and efficacy.
 - Provide hope that there is an end in sight to the pandemic, while getting across that we are not there yet.
 - Ensure diverse reach in communication, including targeted language communities and remote/Indigenous communities.
 - Provide partners, including Health Authorities and other important voices, with the tools to amplify the campaign.
