Dear Contracted Residential Agency Caregiver:

I hope that this letter finds you well. I appreciate all that you and your staff are doing to support the children and youth you are caring for and to keep them connected to their families. As British Columbia moves into a phased restart plan, scaling up in-person connections (visitation) and facilitating access between children, youth and their families is a key and critical priority. I am pleased to share information on the plan to scale up in-person connections between children and youth in care and their families.

On March 26, 2020 a decision to suspend in-person connections for children and youth in care was made with the provision for exceptions. As we move toward scaling-up in-person connections that were in place prior to the decision, it will be important to consider the views and circumstances of the child/youth, the parent(s) the caregivers and the community.

Effective June 3, 2020 we are transitioning to increasing in-person connections for children and youth in care who were having in person connections with their family prior to March 26, 2020.

The Provincial Health Officer (PHO) provided foundational principles that assist in guiding how we collaboratively plan for in-person connections for children and youth in care and their families. Based on the current epidemiology of COVID-19 in B.C. and the fact that children are at a much lower risk of developing or transmitting COVID-19, in-person connections can occur while considering the health and safety of children/youth and adults.

Virtual connections have been a positive way of children/youth connecting to their families and extended families and will never replace in-person connection. Virtual connections through Skype are encouraged to continue, and your resource worker and the child/youth's social worker can assist in ensuring that there are no barriers to providing this virtual connection.
